SURVIVING THE COMMODITY CRUNCI



It's getting harder and harder to thrive and even survive as the cost of the commodities we use every day in our businesses continues to climb. Fuel for our vehicles, energy for our burn and bake ovens, and especially the cost of the copper in our rewinds is spiraling upwards with no end in sight. The only good side (if you can call it that) of this trend is that the cost of new motors seems to be keeping pace with rewind expenses, but our customers (also feeling the pinch) often complain and demand that their suppliers (us) help them by holding down our price increases for rewind and new products!

If only we could demand the same thing of our suppliers, but unfortunately that isn't an option. Still, there are some things that we can do, and this year our Fall Conference program is designed to help us identify the problems and cope with them.

Don Lammers of Vaughen's Pricing Guide will help us understand some of the radical changes that are taking place in the cost of commodities that we use every day in our business. He'll give us a better understanding of the real impact these changes have on our bottom line, and some ways we can take these facts into account as we price our rewinds.


Kevin Henson of Essex will talk about the way we purchase our copper, and introduce strategies (such as tolling) that will help to reduce the bite of sudden increases in the cost of this expensive raw material.

Every motor has bearings, bearings are made of steel, and the cost of steel is rising as well. Wilkerson of Bartlett Bearings and Joe Burgess from Koyo Bearings will talk about bearing prices, how we buy them, and how we can try to insulate ourselves from the uncertain future of bearing prices.

John McFarland, Chairman and CEO of Baldor Motors & Drives will talk about the changing times for motor manufacturers, while we learn some new ways to market ourselves as EASA shops from

As you can see from this graph I "borrowed" from the 14 July 2006 issue of Standard Bank's Research Economics, the rising cost of copper has closely mirrored that of the precious metal gold, but while gold has risen 121% since January of 2001, copper has gone up 316%!

Balloting is finished in the recent bylaws referendum held by the Southeastern Chapter and here are the results:

Although these amendments all passed by large margins, 228 such affirmative votes are included in the results above. 
