# THE SOUTHEASTERN CHAPTER IS DISSOLVED!

IN JUST A FEW SHORT YEARS, YOU COULD BE READING

Okay, I'll admit that headline is startling, inflammatory, and just a little bit deceptive, but (taken altogether) it is also accurate. In just a few years our chapter could become a thing of the past.

Yes, the Southeastern Chapter is one of the strongest, most active chapters in the Electrical Apparatus Service Association. Together with Southwestern, we are one of only two chapters that comprise a single region within the organization, and with over 260 Active Members, we are also the largest single chapter, representing over 10% of this international organization's Active Members. Right now, our chapter is organized, well represented at the International level, and fiscally healthy. So what's the problem?

The problem is *participation*. Our new Board of Directors will soon be constituted, but as I write this article three positions on our board and one officer's chair remain unfilled. We have found prospects (and we are thankful for those who have agreed to serve and those who are considering it) but no more than one in each state. For several years now, few state director elections have been held because more than one candidate for director could seldom be found. Instead of wasting time and money on a meaningless ballot with only one candidate, the Board has simply appointed the only willing person to the post. When the first two-year term was up, the process was repeated. Year after year, the same small group of willing members has met and served this chapter, but now, having fulfilled two two-year terms, some of these faithful can no longer remain in their positions.

Searching for possibilities, we have scoured the registration lists of all chapter meetings for the last few years and have discovered a dismaying fact: while we have good attendance overall, it is usually the same group of people, and almost all of them have now cycled through the Southeastern Chapter leadership positions.

Just a couple of years ago we fought a great battle against overwhelming odds and saved our chapter from dissolution or evisceration. Many of you were roused up and came out ready to fight,

contribute and encourage, and we very much appreciate it. Without you and your support, this article's headline would have already become fact! But now we face a need that is just as vital. We need YOU to get involved in your organization and your chapter. We need you to come to meetings, participate and contribute your time to keeping this chapter healthy.

#### **OUR CHAPTER NEEDS A BLOOD TRANSFUSION!**

We need new blood, new people who are interested in the health of their industry and this association. - (3) Come to our chapter conferences. One of the board meetings will be held in conjunction with our annual Fall Conference, and you will also be expected to attend the conference unless unavoidable circumstances prevent it, help out if needed, and stand around looking good ... if possible.

That's it. Both of these requirements represent an investment of time and money. Is your chapter worth it? A couple of years ago, many of you thought so. Now we need more than just a bunch of angry folks spoiling for a fight. We need people who will sacrifice *just a little* to help keep the Southeastern Chapter healthy. We need you. Isn't it time you got involved?

In the past ten years four EASA chapters have voluntarily surrendered their EASA Charter, disbanding due to apathy and inactivity. Without your participation, in a few years the Southeastern Chapter could be one of them.
